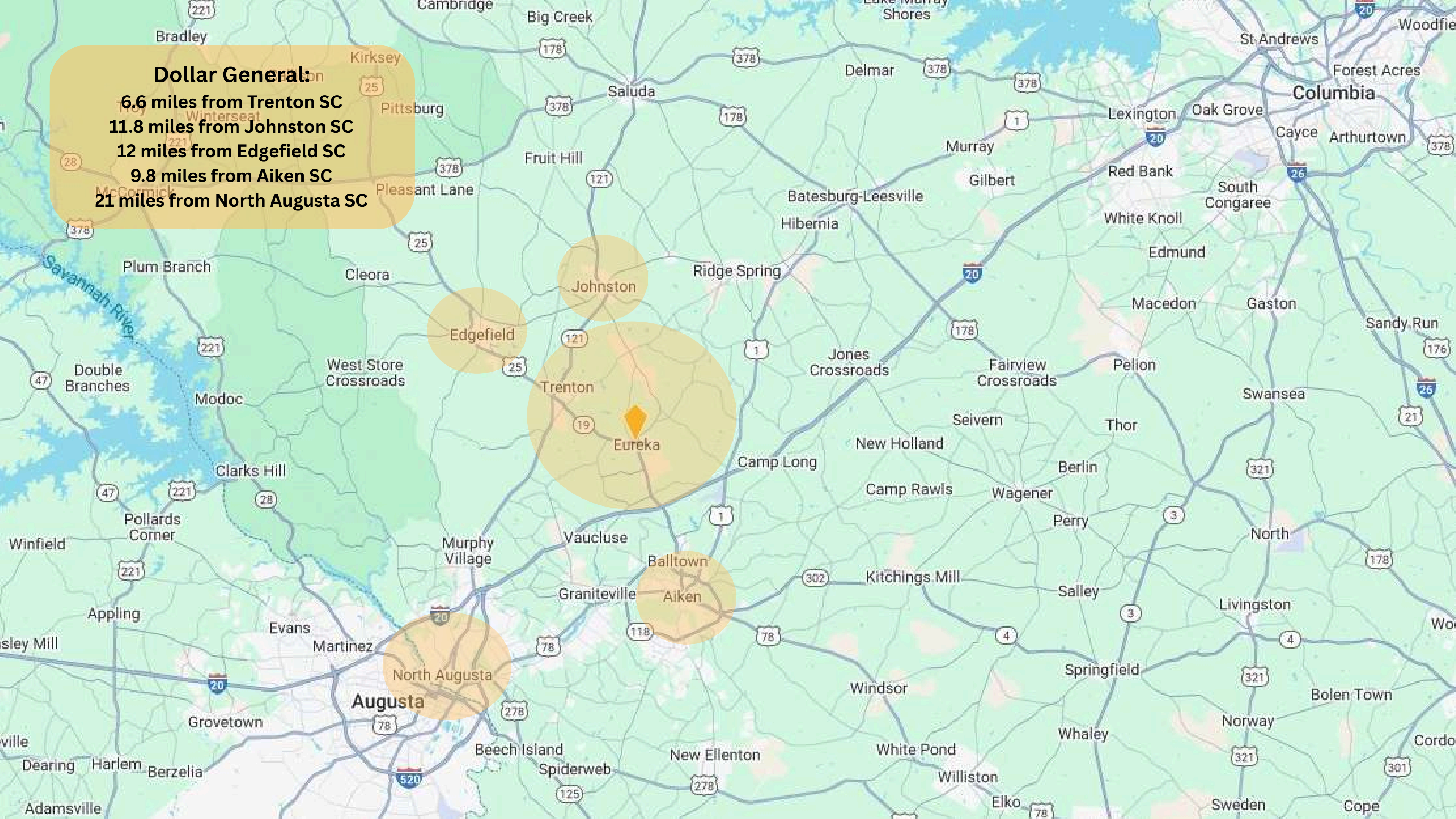

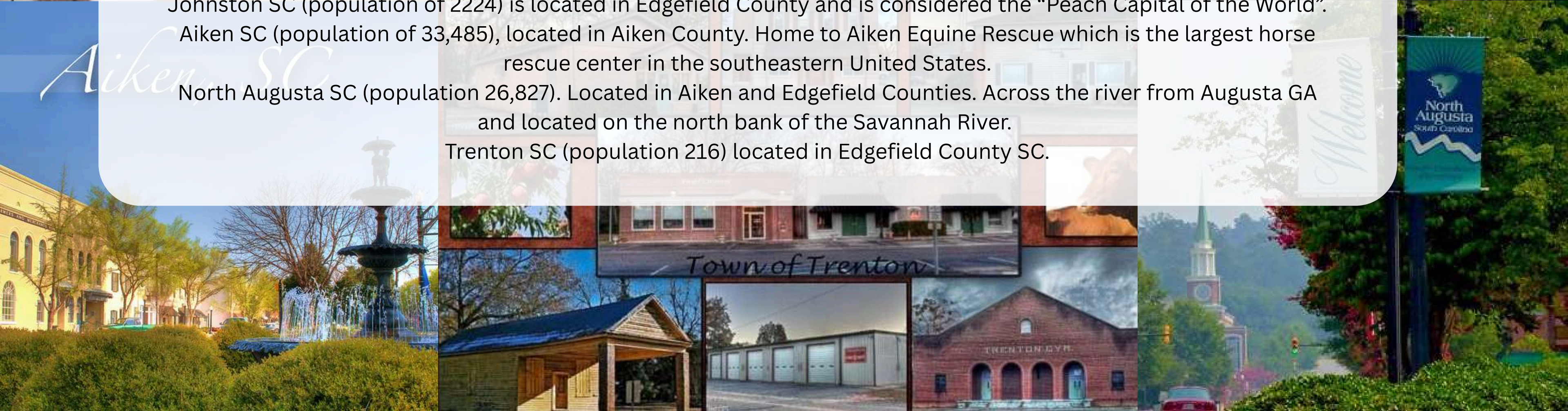
Edgefield SC (population of 4051) is the county seat of Edgefield County (population of 29,455).
